

## Diverclean Endurochlor VE5

### Hazards for humans and the environment



Contains potassium hydroxide (Potassium Hydroxide), sodium hypochlorite (Sodium Hypochlorite), N,N-dimethyltetradecylamine N-oxide (Myristamine Oxide)

**Signal word:**

Danger.

**Hazard statements:**

H314 - Causes severe skin burns and eye damage.  
H410 - Very toxic to aquatic life with long lasting effects.  
H290 - May be corrosive to metals.

### Prevention and conduct



The following information applies for the uses indicated in subsection 1.2 of the Safety Data Sheet. If available, please refer to the product information sheet for application and handling instructions. Normal use conditions are assumed for this section.



Recommended safety measures for handling the undiluted product:

Covering activities such as filling and transfer of product to application equipment, flasks or buckets

**Appropriate engineering controls:**

If the product is diluted by using specific dosing systems with no risk of splashes or direct skin contact, the personal protection equipment as described in this section is not required. Where possible: use in automated/closed system and cover open containers. Transport over pipes. Filling with automatic systems. Use tools for manual handling of product.



**Appropriate organisational controls:**

**Personal protective equipment**

**Eye / face protection:**

Avoid direct contact and/or splashes where possible. Train personnel.



**Hand protection:**

Safety glasses or goggles (EN 166). The use of a full-face shield or other full-face protection is strongly recommended when handling open containers or if splashes may occur. Chemical-resistant protective gloves (EN 374). Consider specific local use conditions, such as risk of splashes, cuts, contact time and temperature.



**Body protection:**

No special requirements under normal use conditions. Wear chemical-resistant clothing and boots in case direct dermal exposure and/or splashes may occur (EN 14605).

**Respiratory protection:**

Respiratory protection is not normally required. However, inhalation of vapour, spray, gas or aerosols should be avoided.

**Environmental exposure controls:**

Should not reach sewage water or drainage ditch undiluted.



Recommended safety measures for handling the diluted product:

**Recommended maximum concentration (% w/w):** 10

**Appropriate engineering controls:**

Provide a good standard of general ventilation. Ensure that foam equipment does not generate respirable particles.



**Appropriate organisational controls:**

**Personal protective equipment**

**Eye / face protection:**

**Hand protection:**

Avoid direct contact and/or splashes where possible. Train personnel.

Safety glasses or goggles (EN 166) are always recommended for foam applications.

Chemical-resistant protective gloves (EN 374) are always recommended for foam applications. Consider specific local use conditions, such as risk of splashes, cuts, contact time and temperature.

**Body protection:**

No special requirements under normal use conditions.

**Respiratory protection:**

No special requirements under normal use conditions.

**Environmental exposure controls:**

Should not reach sewage water or drainage ditch undiluted.

### Emergency procedure



**Suitable extinguishing media**

Carbon dioxide. Dry powder. Water spray jet. Fight larger fires with water spray jet or alcohol-resistant foam.

**Environmental precautions**

Do not allow to enter drainage system, surface or ground water. Do not allow to enter the ground/soil. Dilute with plenty of water. Inform responsible authorities in case undiluted product reaches drainage system, surface or ground water or the ground/soil.

**Methods for cleaning up**

Ensure adequate ventilation. Dyke to collect large liquid spills. Absorb onto dry sand or similar inert material. Do not place spilled materials back into the original container. Collect in closed and suitable containers for disposal.

### First aid measures



**Inhalation:**  
**Skin contact:**

Get medical attention or advice if you feel unwell.

Wash skin with plenty of lukewarm, gently flowing water for at least 30 minutes. Take off immediately all contaminated clothing and wash it before reuse. Immediately call a POISON CENTRE, doctor or physician.



**Eye contact:**

Hold eyelids apart and flush eyes with plenty of lukewarm water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTRE, doctor or physician.

**Ingestion:**

Rinse mouth. Immediately drink 1 glass of water. Never give anything by mouth to an unconscious person. Do NOT induce vomiting. Keep at rest. Immediately call a POISON CENTRE, doctor or physician.
