

Dear Customer,

The Control of Poisons and Explosives Precursors Regulations 2023

New regulations are in place across England, Scotland and Wales which require that from 1st October 2023, for substances which can be used to make home-made explosives (known as Explosive Precursors) or which contain certain poisons, sales can be made to identified professional users only. These substances are now known as **Regulated Substances**.

The list of products sold by Hugh Crane Cleaning Equipment which contain **Regulated Substances** is below.

For us to continue to supply any of our customers with any of these products we are now legally required to collect from you the following information in the form of a signed customer statement to ensure legitimate business use:

Your business name and address	The nature of your business, trade or profession, or your EPP licence	Your VAT number (if registered)
The name(s) of your authorised representative(s), including a copy of their photographic ID (passport, driving licence, business ID). This person(s) should be “authorized on behalf of the customer” – possibly a manager, director, or other responsible person.		

We appreciate that this is a change to the way we’ve previously been able to supply products to you, but it is now a legal requirement. Please accept our assurance that we will do everything we are able to minimise disruption during the implementation of these new regulations.

In addition we are required to make all our customers aware that all of us (suppliers and authorised purchasers) are required to inform the authorities in the case of any suspicious transactions, disappearances or theft of either products containing any **Regulated Substance** or substances on the separate **Reportable Substances** list.
